**Answer:** The Mathematics Standards Advisory Panel (AP) will meet Wednesday, January 24, from 10 a.m. – 5 p.m. ET, at the Kentucky Department of Education, 300 Sower Boulevard, 1st Floor, Conference Room C, in Frankfort. The panel will continue its work Thursday, January 25 and Friday, January 26 from 8 a.m. – 4:30 p.m. ET, at the Holiday Inn, 1000 Vandalay Drive, Main Conference Room, in Frankfort. Senate Bill 1 (2017) calls for the Kentucky Department of Education to implement a process for reviewing all academic standards and aligned assessments beginning in the 2017-18 school year. The current schedule calls for one or two content areas to be reviewed each year and every six years after that on a rotating basis The Mathematics Standards Advisory Panel is comprised of 29 members including elementary, middle and high school teachers, members from postsecondary education, and representatives from the Kentucky business community.
